ABSTRACT

This collection consists of the personal correspondence, family genealogy records, published materials, a family bible, and photographs from the Fairbanks Family, the Fairbanks Family in America Inc.

ARRANGEMENT AND PROCESSING NOTES

This collection was re-arranged in chronological order of materials to make ease of use. All non-archival duplicate materials were removed from the collection placed into Genealogy files available to researchers in main Research Library.

COLLECTION DESCRIPTION

This collection Fairbanks Family collection spans two boxes of materials originating from 1698 to the 1990s. This collection is divided into five series relating to the Fairbanks Family: Jason Fairbanks, Fairbanks Documents, Genealogy, Photographs, and The Fairbanks Family in America Inc.

The Jason Fairbanks papers and materials include trial information, detailed accounts, witness statements, and history of Jason Fairbanks and Eliza (Elizabeth) Fales. These papers follow the murder, trial, and execution of Jason Fairbanks and how the town of Dedham reacted to the tragedy.

Fairbanks documents include deeds, marriage licenses, journals, and pay-out from wills to a variety of members of the Fairbanks Family, including: Jonathan Fairbanks, Mary Fairbanks, Prudence Fairbanks, Jarvis Fairbanks, and S.J. Fairbanks.

All genealogy materials relate to the Fairbanks family and start in England and follow the family through to the 20th century.

Photographs detail mostly of the Fairbanks home in Dedham, MA, known as the oldest still standing wood structure. It was built in 1637.

The Fairbanks Family in America Inc. papers include certificates of membership, personal correspondence, invitations, and information regarding annual meetings and reunions.

BIOGRAPHICAL SKETCH

Jonathan Fairbanks (1594 – 1668)

Jonathan Fairbanks was born in 1594 in England. He emigrated to North American around 1633 and moved to and built the Fairbanks House (the oldest wooden structure still standing in the United States) in 1638. Fairbanks was married to Grace Smith in England in 1617 and the pair had six children together.

Fairbanks was one of the original signers to the covenant in Dedham, MA. He purchased twelve acres of land and built his home. Fairbanks was a member of the First Church in Dedham, MA and prominent figure in the town.

He died on December 5, 1668 and is buried in the Village Cemetery in Dedham, MA. His wife Grace died in 1673 and is buried in the same cemetery with her husband.

Jason Fairbanks (1780-1801)

Jason Fairbanks was born on September 25, 1870 to the prominent Fairbanks Family in Dedham, MA. He was the son of Ebenezer and Prudence Farrington Fairbanks. He is most famous in the family for the murder of Eliza (Elizabeth) Fales, daughter of Nehemiah Fales, also of Dedham, MA.

Jason had been courting Eliza Fales and was hoping to get a decision from her. When on the day of May 18, 1801 he met with Fales and stabbed her eleven times, once in the back. He appeared later that day at the Fales home claiming that Eliza had committed suicide and that he had intended to do the same, but has been unable to. Due to his poor health at the time he was taken into the Fales home and received medical treatment.

Jason was put on trial for the murder of Eliza, he was convicted and sentenced to death by hanging. However, before the execution could take place he was broken out of the Dedham jail by a group of men who believed him innocent of the crime. A \$1,000 reward was offered for the capture and return of Jason.

He was found and returned and on September 10, 1801 he was hanged in the Town Common in Dedham, MA for his crimes. Over 10,000 people showed up to see the execution.

Ann (Duncan) (Gross) Fairbanks (1782 – 1865)

Ann Duncan was born in England to Crawford and Mary Duncan in 1782. She was married to Captain John Gross, they were married on a shipping vessel. She lived with him for a time on board until their son Crawford Duncan Gross was born on board a ship on the coast of Maine.

John went back to see and worked the seas for years. In 1814 he died of Yellow Fever, and since his wife's name was not listed his will was never probated to her.

After the death of her first husband, Ann left England and never returned. She arrived in New England. She met George Fairbanks and the pair were married. She died July 20, 1865 and is buried in Westwood Cemetery.

Prudence Fairbanks (1781 – 1871)

Prudence Fairbanks was the second child and oldest daughter of Mary and Ebeneezer Fairbanks Jr. She never married and never had any children. She inherited the family property and the house upon her mother's death in 1843, making her the seventh generation of Fairbanks to own the house. She lived in the house with two of her younger sisters, Sally and Nancy.
